

COVID-19 has shifted global attention to sustainability




After 20 years of dedication to forests, PEFC's global situation



Certification is a demonstrative evidence of Sustainable management of Forest/ToF/NWF resources

CoC certification = credible assurance to all stakeholders from "source" to "consumer"



What does Chain of Custody certification assure?:

- ✓ Legality: product is 100% legal origin
- ✓ Origin: from well managed forests ensuring ecological, social and economic values
- ✓ Traceability: raw material supply chain is controlled and verified from the source up to the finished products

What is PEFC CoC Certification?



- ✓ PEFC CoC certification provides **independently verified assurance** that wood contained in a product originates from well-managed forests/ToF or other permitted sources (controlled/recycled) with Due Diligence.
- ✓ **PEFC DDS** is an integral part of CoC certification that minimizes risk that timber comes from illegal harvesting and enables companies to demonstrate alignment with regulatory requirements (e.g. CITES listed spp., e.g. Sissoo).
- ✓ **To get PEFC CoC certification**, companies must develop and implement procedures to account for purchasing of wood, tracking, manufacturing, sale and recordkeeping of certified products.
- ✓ Who can get PEFC CoC certification all companies that manufacture, process, trade or sell wood/wood-based products.

Benefits of PEFC CoC Certification



It allows organizations to demonstrate their commitments on sustainability and environmental responsiveness through the entire supply chain and use of PEFC trademark

- ✓ "Sustainable" branding the products
- ✓ Business leadership on sustainability
- ✓ Compliance with legislation
- ✓ Proof of traceability
- ✓ Access to new markets

CoC Certification Types



Single-site Certification:



For companies that operate one facility



For companies that operate several facilities

Group Certification:



For small, independent businesses forming a "group" for the purpose of certification to reduce costs.



For short-term projects involving different, uncertified contractors, such as in construction and building projects, or the one-off production of a specific product.







✓ All contractual companies have access to the PEFC Label Generator for self use









PEFC trademarks usage requirements – Trademarks users



On product

- a) Direct on tangible products
- b) Indirect on media or marketing materials
- c) Direct or indirect material used in production process



Off product

 Any usage not covered by on product

- ✓ The brochure does not need to be certified.
- ✓ The company promoting the certified products is responsible for this usage, not the printer of the brochure (unless they are the same company)



PEFC/FSC are equally accepted and recognized internationally


Business Prospects for Certification Bodies




Sector Insights: Furniture



- ✓ India is a timber importing country but is net exporter of furniture to niche markets in developed countries
- ✓ Employment potential: more than 11.29 million employees by 2022*

Sectors Insights: Paper and paper products



Global situation

- ✓ Worldwide consumption of paper has risen by 400% in last 40 years
- ✓ In the last 20 years, the usage of paper products has increased126%

Indian situation

- ✓ Indian paper industry has over 800 mills with turnover ~ Rs. 70,000 Cr
- ✓ Per capita consumption India 14 Kg. (world average 56 Kg)
- ✓ Employment Generation: Direct 5 Lacs; Indirect 15 Lacs
- ✓ In India, about 90% of domestic industrial wood comes from farm forestry done by Paper Industry and balance 10% from other sources
- ✓ Paper and pulp industry accounts for 36% of industrial wood consumption



Sustainable Public Procurement in India



- Public Procurement is an important contributor to GDP
- Ministry of Finance is engaged with UNEP on prioritization of product categories for implementation of sustainable public procurement (SPP) in India
- SDG 12: Responsible consumption and production
 - ✓ Target 12.7: Promote public procurement practices that are sustainable, in accordance with national policies and priorities



Some examples from GoI

- ✓ Ministry of Finance guidelines emphasize use of National Regulations, Standards or Building Codes for public procurement.
- ✓ CPWD has lifted 25 years old ban on use of wood/ in construction. This should further promote use of certified wood.
- ✓ Government of Uttar Pradesh's notification of 2019 provides for consideration of any scheme, where NABCB provides accreditation or endorsement, to be eligible for assistance for MSMEs

Requirements for CoC Auditors



✓ Based on: Requirements for CBs operating Certification against the PEFC International Chain of Custody Standard (PEFC ST 2003)



Accreditations for CoC

Accreditations accepted by the PEFC Council

Accreditation Bodies signatories of Multilateral Recognition Arrangement (MLA) for product certification of IAF or IAF's Regional Accreditation Groups such as European co-operation for Accreditation (EA), Interamerican Accreditation Cooperation (IAAC), Pacific Accreditation Cooperation (PAC) and Southern African Development Community in Accreditation (SADCA). Like NABCB in India

The scope of the accreditation shall explicitly cover the PEFC Chain of Custody Standard (PEFC ST 2002, Chain of Custody of Forest & Tree Based Products – Requirements) official website www.pefc.org.

The scope of accreditation shall also explicitly state ISO/IEC 17065, this document and other requirements against which the certification body has been assessed.

Notification and Fee for Certification Bodies



- ✓ NCCF notifies CBs for performing FM/CoC Certification audits
- ✓ NCCF notification requires CBs to Notification Fee (to be collected from Certificate holder)
- ✓ Procedure on notification to certification bodies and fee policy available on NCCF website.
- ✓ In order to ensure the independence of certification bodies, NCCF notification conditions decided by the NCCF cover:
 - administrative conditions (e.g. communication of the CB with the NCCF Council, transfer of information, etc.)
 - financial conditions (fees imposed on certified entities)
 - compliance with requirements for certification bodies verified through accreditation as described in this standard.

 - ✓ First training on new PEFC 2020 Standards
 - ✓ National & International Participation
 - √ 31 auditors participated
- ✓ With COVID-19, remote auditing is allowed for CoC certifications

- ✓ Mode: Online


Current Status of PEFC CoC in India



- ✓ PEFC CoC initiation in India: 2015
- ✓ Valid CoC Certificates: 40
- ✓ Notified CBs: 09; Active CBs: 05
 - SCS, SGS, Control Union, TUV-NORD, TUV-SUD, Alko Cert, Soil Association, Preferred by Nature (NEPCon), GICIA India Pvt Ltd.

✓ CBs in pipeline for PEFC CoC notification: 01
