4. Co-opted Member:

Terms & Conditions

- 1. Any person who is competent to enter into a contract can apply for membership.
- 2. The decision for granting and/or rejecting the Membership lies on the Governing Body.
- 3. All the Bodies, firms, corporate Society etc registered or unregistered who become member of the Society shall nominate, in writing, an individual as its representatives supported by the signed Board Resolution/Authority Letter.
- 4. The Admission Fee shall be paid only once at the time of applying for the membership and Annual Subscription fees hall be paid every year on or before the demand is raised by the Society failing which the membership shall be deemed to be cancelled.
- 5. A Membershall cease to be a member of the Society in any of the following events:
 - (a) On their death.
 - (b) By submitting the resignation.
 - (c) If adjudged insolvent.
 - (d) If found to be involved in anti-social activities.
 - (e) If adjudicated by any court of law to be a criminal offender/ proclaimed offender or of unsound mind.
 - (f) If found guilty of anti- propaganda in relation to the aims and objects of the society.
 - (g) If fails to pay the subscription or contribution in spite of demand raised.
 - (h) If disregards the Rules or disobeys the decisions of Governing Body.
 - (i) In the case of a partnership firm, if it is dissolved or adjudged insolvent.
 - (j) In the case of a partnership firm, if the partners are convicted of an offence involving moral turpitude.
 - (k) In case of nominated members, till the time he/she holds the post in the Ministry of Environment.
 - (I) In the case of a company, society or association, it goes into liquidation or is dissolved.
 - (m) In case of continuous breach of the Rules & Regulations of the Society.
 - (n) If it appears to the Governing Body that any member has been guilty of any mis conduct.
